CAP/DEC/1 (VI)

Agenda of the Commission
Agenda item 1 (document CAP/6/Prov. Ag.)

The Commission,

Approves the provisional agenda of its fifth session, with certain amendments,

CAP/DEC/2 (VI)

Nominations by the Commission of its
Candidature to the Vice-Presidency of the Assembly
Agenda item 2(a) (document CAP/6/2)

The Commission

Recalling that, in accordance with Article 13 of the WTO Statutes whereby the General Assembly shall elect its Vice-Presidents at the beginning of each session,

Taking note that, with due regard to equitable geographical representation, one seat of the Vice-Presidency to the General Assembly shall be open to one Full Member of the Commission,

Decides to nominate Japan as its candidate to the Vice-Presidency of the Assembly.

CAP/DEC/3 (VI)

Nominations by the Commission of its Candidature to the Credentials Committee of the Assembly Agenda item 2(b) (document CAP/6/2)

The Commission,

Having taken note that, in accordance with Rule 13 of the Rules of Procedure of the General Assembly, the Assembly shall appoint a Credentials Committee composed of nine delegates of Full Members,

Further noting that, with due regard to fair and equitable geographical representation, one seat of the Credentials Committee shall be open to one Full Member of the Commission,

Decides to nominate to the General Assembly Thailand as its representative to the Credentials Committee.

CAP/DEC/4 (VI)

Mominations by the Commission of its Candidatures to Committee A and B of the Assembly Agenda item 2(c) (document CAF/6/2)

The Commission,

Recalling the Executive Council's decision at its tenth session recommending that Committee A or Administrative Committee and Committee B or Technical Committee shall be established by the General Assembly at its third session,

Having taken note that the Commission may propose its candidatures to the offices of the Committees,

Decides to nominate to the General Assembly the candidatures of Republic of Korea to the office of Vice-Chairman of Committee A and Indonesia to the office of Vice-Chairman of Committee B.

CAP/DEC/5 (VI)

Nominations by the Commission of its Candidature to the Executive Council Agenda item 3 (document CAP/6/3)

The Commission,

Recalling that, in accordance with Article 12 (b) and 14(1) of the WTO Statutes and with Rules 54 and 55 of the Assembly's Rules of Procedure, the Assembly shall elect the Members of the Executive Council in the proportion of one Member of the Council for every five Full Members of the Organization,

Noting that, with due consideration to fair and equitable geographical representation, two seats shall be open to the Commission,

Further noting that the terms of office of Thailand and Indonesia as the Commission's representatives in the Executive Council will expire during the 3rd General Assembly,

Decides to nominate to the General Assembly the Republic of Korea and the Philippines as its candidates to the Executive Council.

Election of Officers of the Commission for Asia and the Pacific Agenda item 4 (document CAP/6/4)

The Commission,

Recalling that, in accordance with Rule 2 of the Terms of Reference and the Rules of Procedure of WTO Commissions, the Commission shall elect a Chairman and two Vice-Chairmen from among its members for a term of two years,

Decides to elect Indonesia as its Chairman and Australia and Japan as its Vice-Chairman for the period 1980-1981.

Congratulates the outgoing Chairman, Thailand for having served the Commission with dedication and firm commitment and support for two terms (1975-1979) and the outgoing Vice-Chairman, Republic of Korea and Malaysia for one term (1977-1079).

Report of the Regional Secretary
on the Viability of Joint Commission Meetings
Aganda item 5 (document CAP/6/5)

The Commission .

Having examined the Regional Secretary's study on the viability of holding joint Seminars and Commission meetings with the Commission for South Asia, pursuant to Decision 5(c)(M) of the 5th CAP meeting,

Considering the historical background of the holding of said joint activities and the ensuing valuable exchange of information and ideas on tourism between the two regions,

Considering further that a joint regional Seminar is part of the regular programme of work of the Organization and the joint Commission meeting is held to enable the Commissions to discuss and act on the recommendations and conclusions of the preceding joint Seminar,

Decides, in the spirit of cooperation and inter-regional understanding, to continue to hold joint seminars and Commission Meetings with the Commission for South Asia.

CAP/DEC/8 (VI)

Report of the Chairman of the Working Party on Hotel Classification Agenda item 6 (document CAP/6/6)

The Commission,

Having examined the Report of the Chairman of the Working Party for Standardized Hotel Classification in the CAP region,

Decides the adoption of the Hotel Classification System for the CAP region, as shown in Annex B of aforementioned report,

Decides further to adopt and approve the following recommendations of the Working Party:

- The classification system shall be a) restricted to hotels;
- The WTO five categories-star system b) shall be adopted,
- The standards/norms for premises, installations, facilities, services, and staff of hotels shall be the minimum requirements for each category;

d) The classification system is only intended to serve as broad guidelines for the countries in the East Asia and Facific region. Their further development and implementation are the joint responsibility of the National Tourism Administrations and hotel trade associations, in accordance with national policy and usage.

Entrusts the Regional Secretary with disseminating the hotel classification system in the East Asia and Pacific region and with rendering a periodic report on its implementation by members in the region,

Congratulates the Chairman and the Members of the Working Party for having completed its very comprehensive work within a period of one year involving two meetings.

CAP/DEC/9 (VI)

Report of the Chairman of the Working Party for the Preparation of the World Tourism Conference 1980 Agenda item 7

The Commission,

Having taken note of the Secretary-General's report to the General Assembly on the preparatory work for the World Tourism Conference,

Desirous of making a special contribution to that work as the host region of the Conference to be held in Manila, Philippines in September 1980,

Endorsos the subject themas proposed by the Secretary General for inclusion in the provisional agenda of the Conference, and in particular with reference to the following subjects:

- the preservation of traditions and cultural heritage
- the coordinated and integrated relationship between Governments and private sectors
- the adoption by Governments of fair and equitable air policies to reduce and indeed abolish constraints of travel by air particularly to the developing countries.

Entrusts the Regional Secretary with the formulation of the appropriate document embodying the aforementioned recommendations and submitting same as part of Agenda document 2/3/13(a).

Expresses its full support and wholehearted cooperation towards assisting the Philippines in the promotion of the Conference in the member-states of the Commission and its high level attendance and participation during the Conference in Manila to ensure its success.

CAP/DEC/10 (VI)

Consideration of the Terminology of the Regional Commission as it

Affects the Commission for South Asia

Agenda item 8(a)

The Commission,

Having considered the proposal of the WTO Commission for South Asia on uniform terminology of the Regional Commissions pursuant to Decision 8(b)(II) of the Second Joint Meeting in Bangkok on 28-29 September 1978,

Recalling the General Assembly's resolution (A/RES/26(II) in defining the terminology of WTO Commissions.

Recalling further the decision of the Commission (CAP/DEC/12(V) at its 5th Meeting whereby the Commission was not in a position to act favourably on the request of the Commission in view of the 2nd General Assembly's resolution on the matter,

Considering the intention communicated by the Commission for South Asia, through its Regional Secretary, of its proposal to the 3rd General Assembly for the amendment of Assembly Resolution 26(II) specifically as it concerns the title of the WTO Commission for Asia and the Pacific,

Decides, in the spirit of cooperation and inter-regional solidarity, to jointly recommend with the Commission for South Asia (CSA) to the General Assembly the amendment of Assembly Resolution 26 (II) whereby the Commission for Asia and the Pacific shall in the future be called Commission for East Asia and the Pacific and the acronym CAP shall be retained.

CAP/DEC/11 (VI)

Report of the Regional Secretary on the Regional Work Program for the Remaining Period of 1979 Agenda item 3(b)1

The Commission,

Having taken note of the report of the Regional Secretary on the regional work programme for the remaining period of 1979 (July-December 1979),

Approves the following recommendations of the Regional Secretary:

- a) deferment for 1980 the Morkshop on Integrated Planning originally scheduled in Manila in August 1979 in view of the Working Party on Hotel Classification in Manila in August 1979.
- b) deferment for 1980 the Study Cycle on General Tourism Administration originally scheduled in Manila in November 1979 in view of possible financial assistance from UHDP which necessitate a longer period to cover preparation of project document and concomittant negotiations with UNDP. This recommendation would alleviate the financial burden on the Philippines as host country for this regional project considering its generous support towards WTO activities in the region.

CAP/DEC/12 (VI)

Report of the Regional Secretary on the UHDP-assisted Technical Cooperation Project for the ASEAN Agenda item 8(b) 2

The Commission,

Having heard the report of the Regional Secretary on the proposed preparatory assistance project entitled ASDAN Cooperation in Tourism Development, a UNDP-assisted project amounting to \$103,500 with WTO as the executing agency in association with ILO,

Expresses its satisfaction over the project,

Entrusts the Regional Secretary with providing the ASEAN members of the Commission copies of the final document to allow them ample time to prepare for the activity;

Entrusts further the Regional Secretary to communicate with the Secretariat General its desire that a similar project be extended to the other countries in the East Asia and the Pacific region.

CAP/DEC/13 (VI)

Proposed Topics for Joint CAP-CSA Seminar in Sri Lanka, 1980 Agenda item 3(c)

The Commission,

Recalling its parlier decision (DEC 8(VI) on the holding of the Joint CAP CSA Seminar in Sri Lanka in 1980.

Entrusts the Regional Secretary in recommending the topic for the joint seminar, bearing in mind the areas of priority concern in the East Asia and the Pacific region and at the same time of interest to the South Asia region, and to inform the Commission accordingly.

CAP/DEC/14 (VI)

Election of Members in the Executive Council Agenda item 8 (d)

The Commission,

Having examined General Assembly document A/3/20 on the elections to the Executive Council which outlines the consequences which the foreseeable increase in

the number of Full Members of the Organization and the resultant changes in the membership of the Regional Commissions will have for the membership of the Executive Council and thus for the elections to the Council at the present session of the Assembly,

Aware of projected moves of certain Full Members towards recommending to the General Assembly only 10 available soats for election, thus pegging the total number of the Executive Council at 20,

Racognizing the implications of such a move whereby there are 11 seats to be vacated and therefore a certain region may be placed at a disadvantage,

Decides to recommend to the General Assembly to consider the desirability of increasing to twenty-one the member of Executive Council Members and of electing eleven new Council Members at the present session.

CAP/DEC/15 (VI)

Place and Date of Next Meeting Agenda item 9

The Commission,

Entrusts the Regional Secretary with consulting the Chairman (Indonesia) of CAP on the place and date of the 7th CAP meeting, bearing in mind the WTO activities in the region and the meetings of WTO organs in 1980, and with communicating same to the Members.
