- 1. <u>Decides</u> to nominate the following candidates to represent the region on the subsidiary organs of the Executive Council whose term of office will be four years commencing from the ninth session of the General Assembly:
 - (a) Technical Committee for Programme and Coordination (TCPC): China;
 - (b) Committee on Budget and Finance (CBF): Democratic People's Republic of Korea;
 - (c) Facilitation Committee: Republic of Korea;

- (d) Environment Committee: Japan;
- (e) Safety Committee: Japan; and
- Also decides to nominate Indonesia as its candidate to represent the region on the Sub-Committee for the Review of Applications for Affiliate Membership for the period 1991-1993.

<u>Decides</u> to propose China and the Republic of Korea to the General Assembly as candidates to the vacant posts on the Executive Council corresponding to two full sets of five Members within the region of East Asia and the Pacific for the period 1991-1995.
