Decides further to hold a Workshop on Cultural Impact of Tourism in the countries of South Asia in April/May 1983, which shall precede its thirteenth meeting;

Decides further to hold a Workshop on Convention Marketing and Incentive Travel in India or Sri Lanka in November/December 1983, with the understanding that, if the Organization's general programme budget for the period 1982-1983 is unable to support the foregoing three workshops, the Workshop on Cultural Impact of Tourism in the countries of South Asia will be financed from the funds at the disposal of the Members of the Commission.

REPORT ON THE COMMISSION'S PROGRAMME OF WORK FOR 1980-1981

Agenda item 13 (document CSA/12/13)

The Commission,

Having taken cognizance of the progress of Members in the implementation of the Commission's programme of activities for 1980-1981,

<u>Decides</u> that the Members of the Commission continue the implementation of the Joint Promotional Programme as follows:

- 1. Folder and poster on South Asia -
 - Requests the Members who have not supplied the required photographic/editorial material to submit same by 15 August 1982;
 - ✓ Requests Pakistan to submit a new quotation for printing which is valid up to 31 December 1982;

Affirms that the reasonable increase in cost be met from the funds at the disposal of the Members, and

Requests the Members who have not sent their share of the cost of production to do so by 31 August 1982 or indicate when same can be sent.

2. Consumer publications -

Requests the Members who have not sent their contribution of US\$ 1,400 each for 1981-1982 to do so before 31 August 1982;

Affirms the annual contribution of US\$ 1,400 per Member of the Commission to be sent hereafter by 31 March of each year.

3. Special-interest tours -

Establishes a Study Group on Mountaineering and Trekking with Capt. Kohli of Air India as coordinator;

Requests Members to send their experiences to the Study Group which will meet after the Conventions in Appal and Takistan;

Requests the Study Group to submit its recommendations to the Members of the Commission on the occasion of its thirteenth meeting;

Requests the Secretary-General to take the appropriate measures for the implementation of this decision as a special service to a particular group of Members of the Organization.
