The Commission,

Having heard the Communication of the Secretary-General as presented by the Deputy Secretary-General, as well as the clarifications provided by him on various matters raised by the Members;

Takes note of the activities carried out by the Secretary-General since the fifth session of the General Assembly in October 1983, particularly the follow-up action taken in respect of resolutions 123 (V) on the Powers, authority and responsibilities of tourism administrations, 125(V) on WTO's central and decisive role in the field of tourism, and 124(V) on the Technical cooperation activities of the Organization;

Recognizes the concern expressed by the Secretary-General regarding the activities engaged in by certain intergovernmental bodies in the field of tourism, whose initiatives result in duplication of efforts and waste in human and financial resources;

Recalls the decision taken at its thirteenth meeting held in Tehran (Iran) in August 1983, inviting the Members to ensure the central and decisive role of the Organization in the field of tourism;

Entrusts the Secretary-General with taking the appropriate action towards concluding a working agreement of consultation and cooperation with the United Nations Economic and Social Commission for Asia and the Pacific, as he has done with the United Nations Economic Commission for Africa, in order to avoid overlapping of activities and resulting distortions;

Appreciates the information provided on the present situation of the movements of persons in the world and the magnitude of the under-utilized potential demand, the standard-setting role and activities of the Organization and the progress made in the implementation of the general programme of work for 1984-1985, particularly in the fields of youth tourism, technical cooperation and vocational training;

Notes with satisfaction the plans and programmes being developed for the rest of the biennial period including, among others, the organization of an international seminar in 1985 on the vital subject of tourism training;

Expresses its cooperation and participation in the celebration of the 10th anniversary of the Organization and the 60th anniversary of the former IUOTO, as well as the 5th centenary of the discovery of the Americas.

The Commission,

Having examined the report on the operational activities carried out in the region during the period 1983-1984;

Appreciates the information contained therein;

Expresses its satisfaction with the significant increase in operational activities of the Organization, especially the fielding of missions in response to specific needs indicated by Members, as well as the positive results of such missions;

Takes note of the requests from Bangladesh, Maldives and Nepal for assistance in certain fields;

Requests the Members to inform the Secretary-General as soon as possible the priority needs in the tourism sector requiring assistance through missions;

Entrusts Bangladesh, India, Nepal and Pakistan as members of the UNDP Governing Council with taking appropriate measures to help the Organization obtain more funds from the UNDP for sectoral support missions.

TECHNICAL COOPERATION PROJECTS IN SOUTH ASIA Agenda item 6 (Document CSA/15/6)

The Commission,

Having examined the report on the completed, on-going and pipeline technical cooperation projects in the region, and the procedures for obtaining WTO technical assistance annexed thereto;

Takes note of the information contained therein and that provided by the Deputy Secretary-General on the draft statutes of the proposed South Asia Regional Association of Tourism and Hotel Institutes (SARATHI);

Recalls the decision taken at its thirteenth meeting held in Tehran (Iran) in August 1983, urging Governments to give a higher priority for tourism projects in the allocation of resources from the UNDP;

Requests the Secretary-General to explore the possibilities of finding other multilateral or bilateral sources of funding for tourism projects, in view of the financial constraints being faced by the UNDP;

Welcomes the implementation of the WTO/UNDP project "Regional cooperation in tourism training", which was initiated at the request of the Commission;

Provides the following guidelines for the revision of the draft statutes of SARATHI:

- i) Formation of SARATHI to be under the auspices of the Commission, which will have overall responsibility on matters of policy;
- institutes in the ten countries covered by the above project;
 - iii) Election of office bearers to be by country at a Commission meeting, on the basis of one vote per country for those covered by the above project;
 - iv) Each country elected as an office bearer will nominate the person from the Institute to hold office;
 - v) Countries without a tourism or hotel training institute at present will have the right to vote, but will not be entitled to hold office;
- vi) The Secretariat will rotate between the countries and and not be located permanently in any one country;

The Commission,

Having examined the report on the implementation of the joint promotional activities of the Members;

Notes with satisfaction the information contained therein;

Decides to continue implementation of these activities as follows:

1. Publicity Material

- i) welcomes that the joint poster and English version of the folder have been published and the other language versions are being printed;
- ii) notes that Nepal and Sri Lanka will make arrangements for the collection/dispatch of their copies;
- iii) requests the Members who have not sent their share of the cost of production to do so without any further delay.

2. Consumer Publications

- i) appreciates the publication of "Focus on South Asia" by SITA World Travel (India) Pvt. Ltd. in 1984;
- ii) notes the difficulties they are encountering to obtain suitable material for publication;
- iii) entrusts the Secretariat with deciding on whether to continue sponsoring Consumer Publications, depending on the responses received from Pakistan and SITA World Travel (India) Pvt. Ltd.;

3. Special Interest Tours

- ii) authorizes production of an audio-visual presentation on Himalayan Tourism, whose cost is to be met from funds available in the Fund in Trust, supplemented by contributions from India, Nepal and Pakistan if necessary;

- iii) invites India, Nepal and Pakistan to provide Capt.
 Kohli as Coordinator of the Working Group with 200
 slides each, needed for the production of the presentation;
 - iv) requests Capt. Kohli to submit the text of the presentation to India, Nepal and Pakistan for approval;
- v) welcomes the offer to devote one day during the Himalayan Mountaineering and Tourism Convention to be held at Darjeeling (India) from 15 to 17 May 1985, to a workshop on "Promotion of Himalayan Tourism" under the auspices of WTO.
- 4. Coordination of Promotional Activities
 - i) accepts the proposal by India and Sri Lanka for direct mailings of the joint folder in selected markets, whose cost is to be met from the Fund in Trust;
 - ii) notes that India and Sri Lanka will participate in all seven joint promotions proposed, while Maldives will do so in four;
 - iii) requests Bangladesh, Nepal and Pakistan to confirm as soon as possible their participation in the joint promotions;
 - iv) notes that the cost of these joint promotions will be met by the participating countries.
