- 1. Expresses its appreciation to the outgoing Members; and
- 2. <u>Urges</u> the new Members to contribute effectively to the work of these organs as representatives of the Commission during the period of their mandate.

OPERATIONAL ACTIVITIES IN SOUTH ASIA

Agenda item 5 (document CSA/20/5)

The Commission,

Having examined the report on the operational activities carried out in the region since the eighteenth meeting of the Commission (Dhaka, September 1986),

1. Expresses its appreciation of the excellent quality of the operational work carried out in the region including organization of technical meetings, fielding of sectoral support and operational missions in response to specific requests from Members and the execution of technical cooperation projects both at the country and regional levels;

- 2. Commends in particular the UNDP/WTO Regional project "South Asia Regional Cooperation in Tourism Training" for the positive contribution it has made to the updating and improving of the technical capabilities of officials of the national tourism administrations and the faculty members of the tourism and hotel training institutes of the region;
- 3. Expresses its concern about the delay in the approval by UNDP of the second phase of this project to which it attaches the utmost importance since it would complement and bring to fruition a well-commenced job and at the same time cover areas not yet dealt with during the first phase of the project.
- 4. <u>Urges</u> Members who have not yet identified their needs for sectoral support missions for 1988 to do so most urgently, as it might still be possible to include such requests in the proposal to UNDP for the 1988 sectoral support programme;
- 5. <u>Invites</u> Members who have benefited from those missions that resulted in project proposals, to approach their coordinating agencies for external financial assistance with these proposals in order to secure UNDP or other multi-bilateral funding for the projects;
- 6. Requests the Members to ensure that, when nominating candidates for UNDP-funded training, due attention should be given to the claims of eligible women candidates, in line with the resolutions adopted by the United Nations General Assembly as well as by the governing bodies of several agencies and organizations of the UN system.

CELEBRATION OF WORLD TOURISM DAY

The Commission,

Having considered the report on the celebration of World Tourism
Day 1986,

Having heard statements from the representatives of Bangladesh, India, Maldives, Nepal and Sri Lanka on the measures taken in their respective countries for the celebration of the event in 1986 and, in some cases, also in 1987,

- 1. Notes with satisfaction the various activities carried out by member States on the occasion of World Tourism Day;
- 2. Encourages member States to pursue their efforts to organize similar and further activities for the celebration of World Tourism Day 1988.

The Commission,

- 1. Notes with satisfaction the information contained in the document and in the three tables annexed thereto;
- 2. Thanks Maldives, Pakistan and Sri Lanka for their assurances to settle the amounts due from them;
- 3. Takes note of the outstanding contributions from Members as of 31 October 1987;
- 4. <u>Urges</u> Members to settle their outstanding contributions to the Fund in Trust without any further delay.

JOINT PROMOTIONAL ACTIVITIES OF THE MEMBERS OF THE COMMISSION

Agenda item 8 (document CSA/20/8)

The Commission,

Having examined the progress report on the implementation of the joint promotional activities of the Members of the Commission,

Ι

- 1. Notes that the only pending issue with regard to the printing of the joint poster and folder is the return of the expired Bank Guarantee No. 12/40 of 2 April 1984 by Elite Publishers Ltd. of Pakistan to the Indian Overseas Bank (IOB), Colombo;
- 2. Thanks the representative of Pakistan for this offer to assist the Secretariat's efforts in persuading Elite Publishers Ltd. to return the above Guarantee;
- 3. <u>Decides</u> to close the IOB account once all pending sums have been released in order to centralize the Fund in Trust's finances in its Madrid account;

Joint poster and folder ΙI

4. Takes note of the Members' wish to enlarge the scope of the Calendar of Youth Events produced in 1985 by producing a Calendar of Major Events to be held in the region;

Calendar of Events

- 5. Decides that such a Calendar should be produced for the year 1989;
- 6. Thanks Sri Lanka for its offer to coordinate the production of the Calendar as they did for the Calendar of Youth Events in 1985;
- 7. <u>Invites</u> Sri Lanka to submit a cost estimate for the production of the Calendar at the twenty-first meeting of the Commission so that a decision can be taken on the subject;

III

Consumer publications

- 8. Takes note of the latest situation with regard to the consumer publications;
- 9. Requests Bangladesh and Pakistan to settle their outstanding contributions in this respect so that this account could be closed;

IV

Audiovisual presentation

- 10. Recalls its earlier decision CSA/DEC/13 (XVI) authorizing US\$ 2,000 to be met from Commission funds and the balance from contributions of US\$ 1,000 each from India, Nepal and Pakistan towards the cost of production of the audiovisual presentation on Himalayan Tourism entrusted to Air India;
- 11. Requests Air India to contact all the countries that provided them with slides for use in the presentation with a view to finding out if they would like to replace them with new ones;
- 12. Authorizes the payment from Commission funds of US\$ 2,000 to Air India for the production of the audio-visual presentation once India, Nepal and Pakistan have notified the Secretariat of their approval of the script;

13. Takes note of India's proposal to organize a joint promotional evening in Tokyo in conjunction with the JATA Mart;

Joint promotional evening

14. Invites India to prepare a detailed proposal with an estimate of the costs involved in organizing such a joint promotional evening in Tokyo either in conjunction with the JATA Mart or independently and send it within three months to the Members of the Commission for their comments before submitting the final version to the Commission at its twenty-first meeting;

VI

- 15. Thanks India and Sri Lanka for the marketing proposals submitted by them for possible funding by the European Economic Community (EEC);
- 16. <u>Is of the view</u> that a more detailed and comprehensive proposal with adequate justification needs to be prepared for submission to the EEC;
- 17. Considers it more appropriate and more effective for the proposal to concentrate only on marketing and promotion of the region in the main European tourist-generating markets;

Marketing proposal for EEC funding

- 18. Invites Members to examine carefully the proposals of India and Sri Lanka and forward to the Secretariat their considered views, ideas and suggestions together with cost estimates, wherever feasible, with a view to making the proposal as comprehensive and convincing as possible;
- 19. Requests the Secretariat to further improve and refine the proposal with the help of contributions received from Members and to submit it in the appropriate format of a project document to the EEC;
- 20. Expresses the wish that the provision of funds for this project should be over and above the committed financial assistance which the EEC is providing to the countries of the region;

VII

Participation in ITB 21. <u>Invites</u> the Secretariat to explore the possibility of coordinating the participation of countries from South Asia in ITB in order to project a more effective regional image, the more so as PATA has expressed its intention not to play this role any further;

VIII

22. Notes with interest the invitation of the WTO Commission for Europe to the Members of the Commissions for South Asia and East Asia and the Pacific to attend, in conjunction with its eighteenth meeting, a two-day meeting in Crete (Greece) on 8 and 9 June 1988 as detailed in the document distributed by the Secretariat;

Joint meeting with CEU

- 23. Commends the Commission for Europe for its positive initiative which deserves due credit and support;
- 24. Thanks India and Pakistan for their offer to prepare papers on "Partnership in Development" and on "Enlargement of Mutual Tourism" respectively for presentation at the above meeting;

- 25. Believes the presence of the leading European tour operators to be of the utmost importance for the success of the meeting;
- 26. <u>Urges</u> the Commission for Europe to ensure the presence of such tour operators as well as other interested parties by extending invitations to them sufficiently early in 1988.

REGIONAL IMPLEMENTATION OF THE GENERAL PROGRAMME OF WORK FOR 1988-1989

Agenda item 9

The Commission,

Having heard the presentation of this item by the Deputy Secretary-General,

Conscious of the need for the Commission to contribute effectively to the implementation of the Organization's general programme of work for 1988-1989, particularly at the regional level,

- 1. <u>Calls upon</u> Members to come forward with concrete proposals in the four priority areas that have been identified and included in the Organization's general programme of work for 1988-1989;
- 2. <u>Welcomes</u> India's offer to host a seminar on tourism legislation with emphasis on the security and protection of tourists and tourist facilities as a positive contribution in one of the above-mentioned priority areas;
- 3. <u>Decides</u> to hold this seminar in the last week of April 1988 at a place to be determined by the Government of India in consultation with the Secretariat;
- 4. <u>Urges</u> Members to promptly send their comments to the Secretariat on the new revised text of the draft Convention to facilitate travel and tourist stays that will be submitted to the Diplomatic Conference to be convened with the task of finalizing and adopting this international legal instrument;
- 5. <u>Urges</u> those Members who have not yet done so to send their replies to the questionnaire on documentation resources and systems available for the travel and tourism sector before the deadline of 21 December 1987 since this survey constitutes an important input for the success of the WTO project establishing a World Tourism Information Exchange Centre, approved by the Assembly at its last session;
- 6. <u>Invites</u> Members to contribute to the new education and training programme initiated by WTO by devising, in consultation with the Secretariat and with its support, imaginative training programmes at the regional level that would benefit above all nationals of the CSA member countries.
