PRESENTATION OF THE STATISTICAL MONOGRAPH FOR THE REGION AND TOURISM FORECASTS TO THE YEAR 2000 Agenda item 4

- 1. <u>Appreciates</u> the submission of the Statistical Monograph which will be of immense value to the national tourism administrations in the region in planning and marketing activities;

- 3. <u>Urges</u> the Secretariat to distribute the Monograph in advance and incorporate more diversified and qualitative aspects of tourism statistical information; and
- 4. <u>Congratulates</u> the Secretariat for presenting the global and regional tourism forecasts based on the findings of the WTO study on Tourism to the Year 2000.

REGIONAL AND TECHNICAL COOPERATION ACTIVITIES Agenda item 5 (document CSA/28/1)

The Commission,

<u>Having considered</u> the document submitted by the Secretary-General on this Agenda item,

Having heard the views of various Members on the subject,

- 1. <u>Appreciates</u> the decision of the forty-fourth session of the Organization's Executive Council to open a Support Office in Asia which will enable the Secretariat to provide more efficient services to the Members in the Asia-Pacific region;
- 2. <u>Thanks</u> the Government of Sri Lanka for having offered to host and provide facilities for the proposed Support Office;
- 3. <u>Notes</u> the offer of the Government of India to examine the possibility of hosting the Support Office;
- 4. Notes with concern that no external funding is available to implement the activities for the South Asia Tourism Year 1993 and decides that a final decision about South Asia Tourism Year will be taken at the twenty-ninth meeting of the Commission which is scheduled to be held in conjunction with the tenth General Assembly of the Organization;
- 5. Notes with interest that the UNDP's Regional Bureau for Asia and the Pacific (RBAP) has indicated that it would be willing to contribute up to fifty per cent of the total estimated budget for the proposed regional programme, provided that the participating countries agree to contribute the remaining fifty per cent out of their country IPFs or other resources;

- 6. <u>Calls upon</u> the Members to request their respective coordinating units to convey to their UNDP Resident Representatives their willingness to contribute a part of their national IPFs to the proposed regional programme;
- 7. <u>Hopes</u> that in light of the new UNDP policy for project execution, the Organization's technical assistance will continue to be extended to the Members of the Region.

IMPLEMENTATION WITHIN THE REGION OF THE ORGANIZATION'S GENERAL PROGRAMME OF WORK FOR 1992-1993 Agenda item 6 (document CSA/28/2)

The Commission,

<u>Having considered</u> the working document submitted by the Secretary-General on this subject,

- Notes the various activities carried out by the Secretariat in 1992 and the activities planned for 1993;
- Notes with interest that technical seminars on topics of contemporary interest will be organized during 1993 in the Republic of Korea and Malaysia and urges the Members to participate in full strength to draw maximum benefits from these technical meetings;
- 3. <u>Congratulates</u> the Secretariat for having considerably improved the quality and contents of the publications and <u>hopes</u> that these publications will go a long way in assisting the national tourism administrations in their planning and marketing exercises; and
- 4. Takes note of India's offer that one of its national tourism institutes be used as a WTO Education and Training Centre, and the request from Members for increasing the number of scholarships under WTO Scholarship Programme.
