Objectives

- To provide a statistical method of estimation for employment related to the presence of an additionnal population: tourists
 - On any type of territory
 - Homogeneous and comparable
- Method suggested and carried out by the French National Institute
- Implementation by the regional directions of Insee and the Tourism Administration

The tool founding the method

- « DADS » : administrative declaration of the private employers, wich makes it possible to know for any employee :
 - Dates and duration of the contracts
 - Characteristics of the establishment
 - · Activity, number of employes, geographical localization ...
 - Individual characteristics of the employees
 - Sexe, age ...

For a given establishment the share of employment related to the presence of tourists depends ...

More or less touristic orientation of its activity

AND

Of its geographical localization

A method in three stages

- Development of a typology of communes (NUTS 5) according to their touristic orientation
- Classification of the activities, according to their level of touristicity
- For each breakdown commune*activity, choice and application of the appropriate method of estimation for associated employment

The typology of communes

Variables used:

- Employment in restaurants
- Restaurant capacity
- Hotel capacity
- Camp-sites capacity
- Second home density
- Presence of a place of interest



The typology of communes

- Score allocated to each commune for each of the six indicators.
- System of weighting for each indicator.
- Total score : sum of partial scores.
- Analysis of the distribution of the total score and determination of three groups of communes:
 well-equipped, fairly equipped and slightly equipped.

Typology of activities

First stage

One retains the activities for which the employees are likely to be in liaison with the tourists.

Typology of activities

- The activities of tourist lodging are regarded as proxy of the tourist frequentation (activities of reference).
- Regression of the daily employment curve for retained activities on reference activities
- The value of the R-SQUARE provides an estimation for the level of touristicity of each activity.

5 classes of activities

- 1. 100% touristic: hotels, camp-sites...
- 2. Strongly touristic: restaurants, « café-tabac », bakery, food stores ...
- 3. Fairly touristic: super et hypermarkets, non food retail stores, small financial establishments...
- 4. Slightly touristic: some of handcraft industries, road transports, entertainment activities ...
- 5. Non touristic








Calculation of touristic employment

- An accounting ...
 - According to the territory
 - According to the activity
- ... with a temporal approach which takes account to the seasons









The calculation of the touristic part of the stabled employment

- One considers a « residential employment » which corresponds to the needs for the usual inhabitants of the territory.
- From the ratio : employment by activity / résident population
 - On the level « bassin de vie »
 - On a fictitious zone made up of the non touristic « bassins de vie »

(bakery: 2,37 workers for 1 000 inhabitants)





The calculation of the touristic part of the stabled employment


- To determine the number of established posts dedicated to tourism, one breaks up the stabled employment into:
 - A share dedicated to the resident population
 - A share dedicated to the tourists
 - In certain cases, a share dedicated to another reason

Results

- Breakdowns on all the crossings territory*activity*period.
 - In number of workers and full time equivalent
 - Expressed as a percentage of the total employment of the zone

Limits

- Only salaried employment is considered.
- Reflection necessary on zoning
 - Adaptation to the local context
 - Better significativity on homogeneus territories and of a certain size
