<u>Having taken note</u> of the report of the Secretary-General transmitting to the Assembly the communications of the Full Members: Ecuador, Iraq, Lebanon, Panama, Senegal, Syrian Arab Republic, Uganda, Venezuela and Yemen and of the Affiliate Member Africa Travel Association, concerning arrears in the contributions of these Members,

<u>Having heard</u> the oral communication of Niger concerning its contribution arrears, and

<u>Having been informed</u> of the written communication of the Libyan Arab Jamahiriya, dated 30 September 1991, concerning its contribution arrears,

<u>Considering furthermore</u> the recommendation made by the Executive Council in decision 15(XLI),

- 1. Approves decision 15(XLI) of the Executive Council;
- 2. <u>Decides</u> to continue to suspend application to Iraq of the provisions of paragraph 13 of the Financing Rules, in view of the communication received from this Member, as well as to the Affiliate Member Tourconsult/Italia which is in the

process of paying its arrear contributions in accordance with the agreed payment plan;

- 3. <u>Decides</u> to suspend application to Ecuador, Lebanon, Libyan Arab Jamahiriya, Panama, Senegal, Syrian Arab Republic, Uganda, Venezuela, Yemen and Africa Travel Association of the provisions of Paragraph 13 in response to their requests;
- 4. <u>Also decides</u> to suspend application to Niger of the provisions of paragraph 13, subject to consideration by the Executive Council of this Member's situation and the plan for payment of its arrears;
- 5. Recalls that suspension of the application of the provisions of paragraph 13 of the Financing Rules is conditional on:
  - (a) immediate payment of the contribution corresponding to the financial year during which suspension of the application of paragraph 13 is granted; and,
  - (b) strict observance of the plan agreed to for the settlement of arrears;
- 6. Requests the Secretary-General to inform Ecuador, Libyan Arab Jamahiriya, Lebanon, Niger, Panama, Senegal, Syrian Arab Republic, Uganda, Venezuela, Yemen, Africa Travel Association and Tourconsult that the decision just taken in their regard remains subject to strict compliance with the aforementioned conditions;

# <u>Progress report of the Secretary-General</u> (January 1990-September 1991)

Agenda item 8 (document A/9/8)

The General Assembly,

<u>Having examined</u> the report of the Secretary-General on the Organization's activities during the period 1990-1991 and on the prospects for its future activities,

Having heard his oral presentation and the discussions that
followed,

- 1. Expresses its appreciation of the analysis submitted to it on trends in world tourism in recent years and in particular on the conclusions that can be drawn concerning the role of the Organization in the face of a major crisis, such as that resulting from the international events of 1990-1991;
- 2. <u>Notes with satisfaction</u> the structural and methodological changes introduced in the organization and operation of the Secretariat since mid-1990 and the results of the conduct of programme activities;
- 3. <u>Highly commends</u> the more active presence of the Organization in the field, which has strengthened the image and attractiveness of the Organization and resulted in the affiliation of several new Members in Latin America, Africa and Asia, as well as many new Affiliate Members;
- 4. <u>Considers</u> the financial situation of the Organization, after careful examination, to be satisfactory from an accounting standpoint but nonetheless troubling in view of the increasing delays in the payment by Members of their contributions and mounting of arrears;
- 5. Appeals, therefore, both to the Secretariat to continue its efforts to increase management flexibility and exercise greater control over fixed costs and to the Members to fulfil promptly and regularly their financial obligations;
