Application of the provisions of paragraph 13
of the Financing Rules attached to the Statutes

Agenda item 1 (documents A/4/1 and A/4/1 Add.1)

The General Assembly,

Having considered the report of the Secretary-General on Members in arrears in the payment of their contributions,

Having also considered the request submitted to it by the Executive Council regarding the application of the provisions of paragraph 13 of the Financing Rules attached to the Statutes of the Organization,

Having examined the case of each of the twelve Full Members and five Affiliate Members referred to in documents A/4/1 and A/4/1 Add.1,

1. Decides to waive the provisions of paragraph 13 of the Financing Rules as they apply to the following Members, whose explanations it deems satisfactory: Bolivia, Dominican Republic, Sierra Leone, Democratic Yemen, Jamaica;
2. Appeals to the Members concerned to fulfil their financial obligations towards the Organizations as soon as possible and, where appropriate, to state any circumstances beyond their control which explain and justify the delay in the payment of their contributions; and
3. Requests the Secretary-General to continue taking appropriate steps to ensure that these Members pay the contributions owing to the Organization.

Amendment to paragraph 13 of the Financing
Rules attached to the Statutes

Agenda item 10(a) (documents A/4/10(a)
and A/4/10(a) Add.1)

The General Assembly,

Having regard to Article 33 of the Organization's Statutes,

Sharing the concern expressed on several occasions by the Executive
Council about the numerous cases of arrears in the payment by Members
of their contributions to the Organization's budget,

Having taken cognizance of the Council's proposal to strengthen the provisions of paragraph 13 of the Financing Rules attached to the Organization's Statutes,

1. Adopts the amendment to paragraph 13 of the Financing Rules proposed by the Council, with some changes, the final text of the amendment reading as follows:
 - "13. (a) A Member which is one or more years in arrears in the payment of its contributions to the Organization's expenditure may not be elected to the Executive Council or hold offices within the organs of the General Assembly.
 - "(b) A Member which is one or more years in arrears in the payment of its contributions to the Organization's expenditure and which has failed to explain the nature of the circumstances surrounding its failure to pay and to indicate the measures to be taken to settle its arrears shall pay a compensatory amount equal to 2 per cent of its arrears, in addition to the said arrears.
 - "(c) A Member which is in arrears in the payment of its financial contributions to the Organization's expenditure shall be deprived of the privileges enjoyed by the Members in the form of services and the right to vote in the Assembly and the Council if the amount of its arrears equals or exceeds the amount of the contributions due from it for the preceding two financial years. At the request of the Council, the Assembly may, however, permit such a Member to vote and to enjoy the services of the Organization if it is satisfied that the failure to pay is due to conditions beyond the control of the Member."
2. Requests the President of the fourth session of the General Assembly and the Secretary-General of the Organization to sign two copies of the present resolution, one of which will be transmitted to the Spanish Government in its capacity as Depositary of the Statutes and the other of which will be filed in the Organization's archives;
3. Recalls that, in accordance with the provisions of Article 33(3) of the Statutes, the foregoing amendment will come into force when two-thirds of the member States have notified the Depositary Government of their approval.

Amendment to Article 37 of the Statutes

Agenda item 10(a) (documents A/4/10(a)
and A/4/10(a) Add.1)

The General Assembly,

Recalling its resolution 28(II) by which it decided to transfer the functions of Depositary of the Organization's Statutes from the Swiss Government to the Spanish Government,

Noting that the Spanish Government became the Depositary of the Organization's Statutes on 1 May 1979,

Considering the wording of Executive Council decision 7(X) recommending that Article 37 of the Statutes be amended to reflect the transfer of the functions of Depositary of the Organization's Statutes from the Swiss Government to the Spanish Government,

Noting that the Secretary-General has notified all the Members of the draft amendment proposed by the Executive Council to Article 37 of the Statutes, thereby complying with Article 33(1) of the Statutes which provides that "Any suggested amendment to the present Statutes and its Annex shall be transmitted to the Secretary-General who shall circulate it to the Full Members at least six months before being submitted to the consideration of the Assembly",

1. Adopts the said amendment to the Organization's Statutes, the text of which is annexed to the present resolution, and which will come into force for all the Members when two-thirds of the member States have notified the Depositary Government of their approval, in accordance with Article 33(3) of the Statutes;
2. Requests the President of the fourth session of the General Assembly and the Secretary-General of the Organization to sign two copies of the present resolution, one of which will be transmitted to the Spanish Government in its capacity as Depositary of the Statutes and the other of which will be filed in the Organization's archives;
3. Recalls that to notify approval of amendments to the Statutes it is necessary to lodge a formal instrument with the Spanish Government, the Depositary of the Statutes.

ANNEX

"Article 37:

"1. These Statutes and any declarations accepting the obligations of membership shall be deposited with the Government of Spain.

"2. The Government of Spain shall inform all States so entitled of the receipt of the declarations referred to in paragraph 1 and of the notifications in accordance with the provisions of Articles 33 and 35, and of the date of entry into force of amendments to these Statutes."

Amendments to the Financial Regulations

Agenda item 10 (b) (document A/4/10 (b))

The General Assembly,

Having taken cognizance of document A/4/10 (b) transmitted to it by the Council,

1. Decides to amend regulation 5 (3), subparagraph (c) of the Financial Regulations to read:

"With the concurrence of the Committee on Budget and Finance, the Secretary-General may carry forward appropriations from the first to the second financial year of each financial period. All appropriations carried forward shall be used in accordance with the approved programme for that financial period."

2. Decides also to amend regulation 10 (2), subparagraph (b) of the Financial Regulations to read:

"The purpose of the Working Capital Fund shall be to advance moneys to the General Fund to finance budgetary expenditure pending receipt of contributions and, with prior authorization of the Executive Council for each particular case, to meet unforeseen needs and exceptional circumstances."

The General Assembly,

Having taken note of the proposals contained in document A/4/10(c) to amend regulations 38, 42, 45, 52, 56 and 66 of the Staff Regulations to add a new regulation 19 bis to the Staff Regulations and to amend rule 7 of the Temporary Staff Rules,

1. Adopts the amendments to regulations 38, 42, 45, 52 and 66 of the Staff Regulations and the amendment to rule 7 of the Temporary Staff Rules, as set out in document A/4/10(c); and

Decides to add a new regulation 19 bis to the Staff Regulations, which will read:

"19 bis. A fixed-term appointment does not carry any expectancy of renewal or of conversion to any other type of appointment. The expiration of a fixed-term contract is not regarded as a termination within the meaning of the Staff Regulations."

Draft Convention on the Privileges and Immunities
of the World Tourism Organization in the
territories of its member States

Agenda item 11(c) (documents A/4/11(c)
and A/4/11(c) Add 1)

The General Assembly,

Having taken cognizance of the report of the Secretary-General on the draft Convention submitted to it in accordance with the provisions of resolution 69(III),

Having heard the various observations by member States on this draft Convention,

1. Considers that the draft Convention on the Privileges and Immunities of the World Tourism Organization in the territories of its member States should be discussed by a diplomatic conference to be held at Headquarters at a date to be decided by the Secretary-General, in agreement with the Executive Council, after consulting with all the member States;
2. Requests the Secretary-General to prepare for the eighteenth session of the Executive Council an information document containing Members' comments on the report of the Secretary-General, REL 1/8, and to provide the necessary information on the structure of the conference and its financial implications.

A/RES/99 (IV)

General programme of work for the period 1980-1981

Agenda item 12 (documents A/4/12 and A/4/12 Add. B.2.2.1., Add. B.2.2.1. Corr.1, Add. B.2.2.2., Add. B.3.2.1., Add. B.3.2.2., Add. B.3.2.3., Add. B.3.2.4., Add. B.4.1.2., Add. B.4.2.1., Add. B.5.2.1., Add. B.7.2.1., Add. B.7.2.1. Corr.1 and Add. B.8.2.2.)

The General Assembly,

Having considered the results of the research and operations activities carried out under the Organization's general programme of work for 1980-1981,

1. Notes with satisfaction the completion of this task;
2. Expresses the wish that transfers of knowledge in this field continue to be effected through the Organization's programmes, progressively and upon a universal basis;
3. Considers that, by means of the contacts and exchanges made possible through its work programmes, the Organization can ensure that knowledge is disseminated upon a universal basis and does not remain confined to the regional level;
4. Expresses its particular appreciation for the stepping up, during 1980-1981, of operational activities, especially field missions and technical meetings, which have enabled the results of research to be field-tested and implemented;
5. Takes the view that these activities have enabled the Organization to play a more operational than deliberative role which accords perfectly with the thrust desired by Members;
6. Hopes that in future the holding of technical meetings and organization of operational and regional programming missions could be encouraged so as to ensure more effective communication of the Organization's research;
7. Expresses the view that the Organization's programmes are an essential means for implementing, collectively and universally, the recommendations contained in the Manila Declaration on World Tourism, adopted by the World Tourism Conference.

8. Considers that the Organization is the agency through which such universal action could and must be concentrated in future;
9. Further notes with satisfaction the decisive and central role played by the Organization for tourism development through technical cooperation financed by multilateral cooperation agencies, notably the United Nations Development Programme;
10. Notes especially the United Nations Development Programme's contribution which made sectoral support missions possible in 104 developing countries;
11. Encourages developing countries to avail themselves of WTO technical cooperation for all facets of tourism development;
12. Takes note of the useful lessons derived from studies, statistics and documentation activities which should lead to a better understanding of tourism, and makes the following specific observations on each of these activities:

Economic Review of World Tourism (1982 edition) (study B.1.1.);
and

World Tourism (reports B.1.2.)

13. Invites the Secretary-General to finalize this study and these reports with the latest information so as to present a picture of world tourism that is as up to date as possible and to distribute the resulting documents for the end of the biennial period 1980-1981;
14. Proposes that in the next edition of the Economic Review the import content of tourist receipts be studied.

Tourism Forecasting (pilot study B.1.3.)

Considering the importance of forecasting for future tourism planning,

15. Notes the accuracy of the forecasts made in the previous pilot study which IUOTO completed in 1970;
16. Further observes that, according to the latest study, the future growth of tourism will be faster in developing countries;
17. Stresses the need for States to play a more active role in formulating social policies that permit freer access to holidays as well as in promotion, tourism area development and improvement and diversification of tourist products;

18. Observes that tourist demand, in particular for domestic travel, has proved to be very resilient and to be ingrained in the lifestyles of many peoples;
19. Invites the Secretary-General to transmit this study to the Regional Commissions during the 1982-1983 biennium for their comments and suggestions;
20. Recommends that a first monitoring exercise as follow-up to the study should take place in the 1984-1985 programme and that this should take account of the comments and suggestions of the Regional Commissions.

Saturation of Tourist Destinations (study B.3.2.1.)

Recalling the variety of situations in which tourist saturation occurs throughout the world,

21. Notes the value of the study on the saturation of tourist destinations for determining tourism-use thresholds to avoid the overload which has occurred in certain resorts with concomitant degradation of the environment and the tourist product;
22. Invites the States Members of the Organization to examine the possibilities of implementing the recommendations of this study in their respective countries;
23. Recommends that the Organization pursue work in this area, especially by conducting studies and holding technical meetings, with a view to proposing universally applicable carrying-capacity standards for tourism;
24. Notes further the spread of a fifth week of annual paid holidays in industrialized countries;
25. States its awareness of the dangers of over-concentration at peak periods which this creates;
26. Invites the generating countries to take steps, in agreement with their respective employers' organizations and trade unions: (a) to promote better staggering of holidays; and, (b) to envisage greater freedom of choice of holiday periods through discouraging annual closure of enterprises.

Consumer Protection and Information for Tourists (report B.3.2.2.)

Recalling what was agreed in the Manila Declaration on World Tourism: the right to access to holidays and to freedom of travel and tourism, a natural consequence of the right to work, entails for society the

duty of providing for its citizens the best practical, effective and non-discriminatory access to this type of activity.

Considering that the protection of the tourist as a consumer is an essential prerequisite for unfettered equal access to tourism and holidays.

27. Notes that legislation and regulations have recently been promulgated to this end;
28. Considers that these measures have been taken not only to protect and to inform travellers but also to enhance trust between the tourist and the travel trade;
29. Considers that mutual confidence is necessary for the development of tourism, both international and domestic;
30. Views as timely the consultations with national consumers' associations arranged by the Secretary-General, given that it was thereby possible to pinpoint the main problems besetting tourists as consumers;
31. Suggests that Members might wish to bear in mind the views of the consumers' associations when drawing up policies for improving tourist products and services as well as consumer protection and information;
32. Further invites Members to have regard to the suggestions put forward in this report concerning facilities required for disabled tourists;
33. Thanks those countries who contributed to the inventory of legislation and regulations concerning the protection and information of the tourist as a consumer;
34. Further notes the interesting possibilities offered by remote data processing as a distribution channel and a means of consumer information;
35. Proposes that further research on this rapidly developing technology might be included in future programmes of the Organization;
36. Suggests that the subject of remote data processing be included in the syllabus of tourism schools;
37. Recommends to member States that when international remote data-processing reservations and tourist information networks are being created, the developing countries should be given the chance to participate upon a just and equitable footing.

Harmonizing the Contents and Presentation of Information Material (preliminary survey B.3.2.3.)

38. Stresses the timeliness of this report, given the growing importance the public attaches to accurate information about tourist destinations and the need to help the travel trade inform its clients better;
39. Indicates the importance which tourism administrations, especially in countries beginning to develop their tourism, should attach to tourist information material intended for the travel trade;
40. Considers that the results of this research could be useful for future work of harmonizing both the presentation and the contents of such information material;
41. Invites the Secretary-General to establish a study group, within the budgetary limits of 1982-1983, to include both the travel trade and Members so as to make a technical evaluation of the results of this survey and to put forward proposals for recommended practices in this field which, after consideration by the Regional Commissions, could be submitted to a future session of the Assembly for adoption.

Promotion Programmes in the WTO Regions (report B.3.2.4. on the six regions)

Considering that the countries of the six regions are attaching growing importance to the promotion of domestic and international tourism, this being reflected in budgetary appropriations of departments responsible for tourism promotion and the status conferred upon them,

42. Stresses the interest expressed by competent national administrations and the other bodies involved in tourism development for coordination of activities and refinement of strategies and promotional tools;
43. Notes that such an improvement presupposes a greater demand for technical and vocational training for tourism promotion;
44. Stresses the importance of checking each country's external tourist image lest short-term considerations introduce distortions which are difficult and costly to correct and which could have undesired consequences for tourist demand;
45. Envisages the preservation of the spirit of collaboration already identified between competent bodies in the same country, as well as the establishment of joint promotional activities, campaigns and programmes with other countries.

The Development of the Accommodation Sector (report B.4.1.2.)

46. Takes note of the substantial increase in worldwide accommodation capacity, estimated at over seventeen million places;
47. Stresses that the trend towards diversification of means of accommodation is continuing, with resultant benefits for the development of various travel motivations, both for domestic and international tourism;
48. Notes the problems created by inflation and high interest rates for balanced development of accommodation capacity especially in the developing countries, since finance of new supply is curtailed and made more burdensome;
49. Notes the speed with which the structure of the accommodation sector is changing, the trend towards concentration and the adoption of new operating methods;
50. Suggests that due account be taken of these factors in developing the new approach which is necessary for tourism vocational training;
51. Recommends that the study of the development of tourist supply be continued in future so as to serve as a reference for economists, the travel trade and other researchers in the field of tourism.

Guidelines on Management Techniques for Tourist Enterprises, with particular reference to the Governmental and Quasi-Public Sectors (handbook B.4.2.1.)

52. Stresses the value of these guidelines applicable to the specific field of promotion of the social, cultural and educational values of tourism linked to the development of domestic tourism and the preservation of the tourist heritage;
53. Considers that in this field public sector tourist corporations have an important part to play;
54. Notes the key role of public sector tourist corporations as executing agencies of tourism policy;
55. Stresses the need for countries to define clearly, for the benefit of these corporations, such matters as their aims, strategies and functional relationships, as well as the part they are intended to play in the development of social tourism and the attainment of social objectives;

56. Echoes the call made in these guidelines in favour of the diversification of tourism policy objectives so as to reflect cultural, social and educational as well as purely economic considerations;
57. Stresses that tourism's profitability should be considered in terms of its effects on the development of society as a whole, using the criterion of social profitability as distinct from the concern with immediate financial returns which motivate private enterprise;
58. Further states its awareness of the importance of employment and training for the management of tourism enterprises;
59. Invites the Secretary-General to extend the consideration given to this subject in Chapter I of the Guidelines.

Guidelines for using National Resources in the Construction and Maintenance of Tourist Plant (handbook B.5.2.1.)

60. Notes that, in accordance with the aims of these guidelines, the position of the developing countries was the focus of attention,
61. Notes that, in the field of construction of tourist plant, the sectoral policy pursued by each country plays an important part;
62. Stresses that this research has thrown light on the numerous possibilities which exist for developing countries to make appropriate use of traditional techniques and to employ indigenous materials and resources in this field;
63. Stresses that the careful selection of national resources and materials not only constitutes a suitable means of containing construction costs, but also of creating a more original form of tourist plant, better integrated with the environment;
64. Observes that inappropriate use and application of national resources may create an artificial or superficial image of a country;
65. Stresses that the construction and maintenance of tourist plant intended for domestic tourism is an especially apt field for the priority use of indigenous techniques, materials and resources;
66. Highlights the important role which financial and technological cooperation may play in promoting better use of national resources for this purpose;

67. Recommends that maximum use be made of the experience accumulated by the Organization in order to develop this technological cooperation;
68. Recommends that the tourism policy of each country should encourage a balanced use of national resources so as to highlight the distinctive characteristics of each tourist destination, as required by evolving demand;
69. Stresses the practical orientation of these Guidelines;
70. Invites the Secretary-General consequently to ensure their widest possible circulation among the NTAs of member States.

Social and Cultural Impact of Tourist Movements (pilot study B.7.2.1.)

Recalling the emphasis placed by the World Tourism Conference on the social, cultural and educational dimensions of tourism,

Bearing in mind the desire of the developing countries to develop tourism while avoiding unfavourable social or cultural effects,

71. Stresses the significance of tourism in speeding up social and cultural changes arising from economic development and the spread of mass communications;
72. Observes that, independently of positive and negative aspects arising therefrom, tourism helps promote indigenous cultural values;
73. Stresses that mutual awareness is necessary for mutual understanding between peoples, and that physical presence in the society which it is desired to know better is an ideal means of achieving this understanding;
74. Notes the value of this pilot study for determining the beneficial socio-cultural effects of tourism both in generating and receiving countries;
75. Invites the Members of the Organization to study the possibilities of implementing the recommendations of this study;
76. Recommends that future programmes should include the study of social and cultural effects of tourism.

Preliminary Survey on the Status of Tourist Representations Abroad (report B.8.2.2.)

Considering that this survey enables the most common problems encountered by official tourist representations and their staff to be analysed,

Aware of the growing information and promotion role played by official tourist representations abroad,

Desirous of identifying solutions which would enable official tourist representations to carry out their tasks more effectively and to extend their responsibilities,

77. Decides to transmit this report to the Executive Council for consideration of recommended practices which could be submitted to the States for implementation by suitable methods under the responsibility of the Secretary-General;
78. Invites the Executive Council to submit such draft recommended practices to the Assembly at its fifth session with a view to their adoption;
79. Notes that this procedure is without prejudice to the possibility of drawing up an international convention on this subject at a later stage;
80. Thanks the Members of the Organization which contributed to the survey and made observations upon the results.

Guidelines for the collection and presentation of
domestic tourism statistics (B.2.2.1.)

Aware of the importance of domestic tourism for all purposes in both developed and developing countries,

Considering that the use of a universally accepted definition and common methods for measuring domestic tourism is necessary to ensure the standardization and comparability of domestic tourism statistics at the national, regional and international levels,

81. Invites the member States to take all necessary measures to collect domestic tourism statistics on a continuing basis, using WTO domestic tourism definitions to that end;
82. Requests the Secretary-General:
 - (a) to give the widest distribution to Guidelines for the collection and presentation of domestic tourism statistics for the twofold purpose of making them known and of gathering opinions and comments from the member States;
 - (b) to submit the Guidelines for the collection and presentation of domestic tourism statistics to the Regional Commission for consideration;

- (c) to provide technical assistance in the preparation of domestic tourism statistics to States requesting it.

Guidelines for the collection and presentation of international tourism statistics (B.2.2.2.)

Having taken note with satisfaction of the efforts made in both developed and developing countries for the adoption and application of the definitions of the terms visitor, tourist and excursionist in conjunction with international statistics, as recommended by the United Nations Conference on Tourism and International Travel held at Rome in 1963,

Observing that the elaboration of international tourism statistics still gives rise to specific problems concerning the identification of certain categories of travellers, which is a root cause of the lack of international comparability in international tourism statistics,

- 83. Recommends that governments adopt and apply the standards and methodologies generally followed in the preparation of international tourism statistics in order to bring about better international comparability in tourism statistics;

- 84. Requests the Secretary-General:

- (a) to give the widest distribution to Guidelines for the collection and presentation of international tourism statistics for the twofold purpose of making them known and of gathering opinions and comments from the member States;
- (b) to continue work relating to international tourism definitions and to research into special groups of travellers with a view to drawing up a set of basic recommendations for the purpose of coordinating and standardizing classifications and definitions used in the field of international tourism
- (c) to submit the Guidelines for the collection and presentation of international tourism statistics to the Regional Commissions for consideration;
- (d) to provide technical assistance in the preparation of international tourism statistics to States requesting it.

Documentation and technical information

Conscious of the role played by the WTO Tourist Documentation Centre as a technical information unit designed to further WTO endeavours, particularly the Organization's operations programme,

85. Recognizes WTO's central role in the collection, processing and dissemination of tourism-related technical information;
 86. Requests the Secretary-General to continue the systematic collection of technical data directly and indirectly relating to tourism and to encourage the preparation of technical material for publication in the Organization's Travel Research Journal, the value of which it recognizes as a specialized means of communication;
 87. Invites the member States to intensify their participation and cooperation by regularly transmitting documentation and technical data to WTO in order to enable it to fulfil its function as the international clearing-house for tourism information.

Total amount of the programme budget

The General Assembly,

Having examined the draft programme budget for the financial period 1982-1983 proposed by the Secretary-General in document A/4/13,

Considering that the difficult world economic situation demands increasingly vigorous austerity drives,

1. Recognizes that the said draft programme budget was intended to achieve a degree of economy compatible with effective action by the Organization;
2. Fixes the total amount of the Organization's budget for the financial period 1982-1983 at nine million seven hundred United States dollars, viz. four million three hundred and fifty-one thousand eight hundred and twenty United States dollars for the financial year 1981 and four million six hundred and forty-eight thousand eight hundred and eighty United States dollars for the financial year 1983.

The General Assembly,

Having discussed the proposals contained in report A/4/13 Add.1 of the Secretary-General concerning the decentralization of the Organization's activities transmitted by the Executive Council,

Recognizing that the arguments developed by the Secretary-General reflect genuine situations which require the present system of decentralization of the Organization's activities to be urgently rethought so as to provide a better service to Members, within the framework of available human and financial resources,

Desirous of respecting the principles of economy for which the need is keenly felt on account of the situation of each State in the present world financial crisis,

1. Requests the Secretary-General, in the light of the various submissions made on this subject and within the limits of available budgetary resources, to restructure the field units of the Secretariat so as to enhance the efficiency of the operational services of the Secretariat General in the interest of all Members, and especially the developing countries by adopting all administrative, structural and financial measures which he considers appropriate so as to adapt the Secretariat General's structures and field offices to the Organization's aims;
2. Requests the Secretary-General to keep the Council informed of the measures taken to this end;
3. Further requests the Secretary-General to make the necessary changes to the programme budget arising from the implementation of this resolution, keeping within the budgetary limits fixed for the period 1982-1983.

The General Assembly,

Having reviewed the report on vocational training activities in the field of tourism presented by the Secretary-General,

Considering the importance of human resource development sustaining the social and economic progress generated by tourism in the developed and developing countries,

Recognizing the concerns on the vital role of vocational training expressed by the member States,

Responding to the Secretary-General's request for the General Assembly to enunciate its position on options and approaches in the field of tourism training,

1. Calls upon the Secretary-General to implement gradually, and within the limits of the programme budget for 1982-1983 following education and training activities in the field of tourism:
 - (a) the establishment of a vocational training unit within the Secretariat General to plan, coordinate, and execute training activities, including those of the International Centre for Advanced Tourism Studies (CIEST), regional training centres, and other appropriate activities, such as the study of ways and means of ensuring the equivalence of diplomas in tourism studies and their recognition by the States;
 - (b) the development of information directories pertaining to (a) training programmes, including work-study, available in member States, (b) scholarships and sources of assistance for human resource development, (c) exchange opportunities, and (d) instructional material;
 - (c) the implementation of a programme designed to (a) gather and evaluate training resources such as course catalogues and syllabi, correspondence courses, textbooks, audio-visual aids, and other appropriate educational technology, (b) review and disseminate information on cooperative training agreements and technology exchange, and (c) recommend adaptation and translation of training material to meet the specific needs of WTO regions;
 - (d) the further development of CIEST as the international centre for the training of trainers and human resource managers to strengthen the role of the Organization as the coordinator of a cooperative training system, jointly operated by WTO and existing training institutions, and the promoter of excellence which would meet the internationally accepted standards of accredited schools and universities and professional organizations for the recognition of its credits;

2. Further urges that vocational training be integrated with basic educational programmes designed to improve basic literacy skills, multilingual capacities, and intercultural understanding, as the tourism training should foster improved communications and human relations between visitors and residents at the destination as called for by the Manila Declaration.

Planning, action and strategy for the operational
implementation of the Manila Declaration on World Tourism

Agenda item 15 (document A/4/15)

The General Assembly,

Taking cognizance of the Manila Declaration on World Tourism, which has been distributed to all the Members,

Having before it the report of the Secretary-General on the planning, action and strategy for the operational implementation of the Manila Declaration on World Tourism,

1. Is pleased to have planned, designed and convened the World Tourism Conference held at Manila from 27 September to 10 October 1980, at the invitation of the Government of the Philippines;
2. Considers that the results of that Conference constitute a development of the first importance in all the phases of the evolution of world tourism by conceiving of it in new, realistic and thoughtful terms, insofar as recognition is given to the fact that holiday and recreational travel have acquired a social, cultural, educational and political character of the highest importance in today's world community, without prejudice to the economic contribution which tourism can make to States under the appropriate circumstances;
3. Is of the opinion that the fairness of the considerations and recommendations contained in the Manila Declaration on World Tourism constitute a new and compelling source of inspiration for the States, whereby their policies can be consolidated on the basis of the original objectives determined by the World Tourism Conference;
4. Recognizes that the Conference in itself constitutes only one event in the history of tourism and that its essential value lies, for practical purposes, in the application of its aspirations;

5. Appeals therefore to the Members and to all the States which participated in the Manila Conference as well as all those who are drawn inevitably and irreversibly into the sphere of tourism, to do their utmost to apply the Manila Declaration courageously and with a realistic vision of the future;
6. Believes that the World Tourism Organization has scored a noteworthy achievement by inviting the international community to a global consultation on the problems of tourism in the twentieth century;
7. Requests the States which participated at that Conference to ensure that their deliberations find an appropriate realization with all due respect for national sovereignties and individual constraints;
8. Thanks the international organizations and the Affiliate Members for their useful assistance to that great world meeting in the interest of all interested parties;
9. Adopts in its entirety the report of the Secretary-General on the planning, action and strategy for the operational implementation of the Manila Declaration on World Tourism;
10. Requests the Secretary-General to take the step-by-step action required for the implementation of that planning, action and strategy, by furnishing to the States, the international organizations, the private operational sector and all interested entities such information and assistance as they may call for;
11. Endorses the good wishes extended by the Conference to President Marcos of the Republic of the Philippines and Madame Marcos, to the President of the Conference the Minister of Tourism of the Philippines, Mr. José D. Aspiras, and to the Secretary-General of the Organization, and thanks them.

The General Assembly,

Recalling its resolution 74(III) under which it accepted by acclamation the invitation of the Government of Mexico to hold a World Tourism Meeting in 1982 in order to assess the plans, strategies and actions undertaken with a view to implementing the Manila Declaration following the World Tourism Conference held at Manila from 27 September to 10 October 1980,

Having taken cognizance of the report of the Secretary-General on the World Tourism Meeting in Mexico,

1. Renews the expression of its gratitude to the Mexican Government for its invitation to facilitate the deliberations of the international community concerning one of the most significant developments in the history of tourism, namely the Manila Declaration on World Tourism;
2. Is of the opinion that such a meeting is particularly appropriate as a means of enabling the international community to discuss the most fitting measures for implementing the Manila Declaration;
3. Emphasizes the originality of this method of international consultation designed to orchestrate the action taken on a document as important as the Manila Declaration on World Tourism;
4. Takes note of the report of the Secretary-General and his proposals;
5. Accepts the proposal of the Mexican delegation to hold this meeting at Acapulco from 21 to 27 August 1982;
6. Requests the Secretary-General to take appropriate action in order to prepare the World Meeting in Mexico in close contact and cooperation with the pertinent Mexican authorities;
7. Renews its thanks to the Government of Mexico, convinced that all facilities will be granted to the participants to enable them to deliberate under the best conditions on the agenda submitted to them.

Aware of the importance of this draft for the development of world tourism,

Desirous of enabling States to examine in greater depth the provisions of the said draft,

Decides that the draft Tourism Bill of Rights and Tourist Code shall be submitted to the General Assembly at its fifth session for consideration and approval.

Operation of the WTO Commission for the Middle East

Agenda item 20 (document A/4/20)

The General Assembly,

Recalling its resolution 65(III) on the operation of the WTO Commission for the Middle East,

Having taken cognizance of Executive Council decisions 2(XIII) and 2(XIV),

Taking note of document A/4/20 of 1 September 1981, submitted by the Secretary-General, on the negative results of the efforts made to enable the Commission to function normally,

Having heard the opinion of the Secretary-General that he had explored every possible and reasonable approach open to him under the Organization's Statutes and regulations, without any positive results,

1. Is of the opinion that the general situation presently existing in the Middle East still does not allow the Commission to function normally;

2. Notes, however, the intent of the Members of the WTO Commission for the Middle East to benefit from their membership of the Commission within the framework of the aims of the Organization;
 3. Therefore entrusts the Secretary-General with taking the appropriate measures - including holding meetings, organizing exchanges of views with one or more of the Commission Members and supervising and coordinating the functioning of the Commission in a manner which would enable the Members to benefit from their membership of WTO; and
 4. Considers the above directive an interim measure which aims at respecting the legitimate rights of all Members and is to be adopted until the situation of the region allows the normal functioning of the Commission.
