Report of the Secretary-General on financial matters
Agenda item 3(a)

The Executive Council,

<u>Having taken cognizance</u> of the report of the Secretary-General on the financial situation of the Organization and of the report of the Committee on Budget and Finance,

(documents A/8/11(a), A/8/11(a) Add.1 and CE/36/3(c))

- 1. <u>Notes</u> that during the financial year 1989 a balance has been maintained between budgetary income and expenditure;
- 2. Expresses concern at the delay by some Members of the Organization in paying their contributions for the current financial year and accordingly at their failure to comply with the provisions of paragraph 12 of the Financing Rules attached to the Statutes;
- 3. Entrusts the Secretary-General with ascertaining from each Member which body is responsible for paying its contributions so as to ensure that Members are notified without delay of their contributions and to secure prompt payment; and

4. <u>Unanimously reiterates</u> its decision 4(XXXIV) taken at its thirty-fourth session to recommend the General Assembly to incorporate the surplus of the General Fund of the period 1984-1985, namely 437,750.68 dollars, into the Working Capital Fund, it being understood that this decision is of an exceptional nature and may not serve as a precedent.

CE/DEC/4(XXXVI)

Adjustment of the amount of the Organization's budget for the period 1990-1991 due to application of the United Nations operational exchange rate effective in August 1989 (decision CE/DEC/24(XXXV))

Agenda item 3(b) (documents CE/36/3(b) and CE/36/3(c))

The Executive Council,

Having considered the document concerning the adjustment of the amount of the Organization's budget for the period 1990-1991 due to application of the United Nations operational exchange rate (dollar-peseta) effective in August 1989,

Having also considered the report of the Committee on Budget and Finance,

- 1. Notes that the exchange rate applied at the time of preparing the draft budget was 114 pesetas to 1 US dollar and that the United Nations operational exchange rate effective in August 1989 is 118 pesetas to 1 US dollar;
- 2. Approves the adjustment made by the Secretary-General to the proposed appropriations in document A/8/14, which he based on the United Nations operational exchange rate applicable in August 1989, i.e. 118 pesetas to 1 US dollar;
- Recommends the General Assembly to approve the new level of the budget, reflecting the revised appropriations as submitted in document CE/36/3(b) (document A/8/14 Add.1), and which amounts to 6,965,800 dollars for 1990 and 7,039,400 dollars for 1991; and
- 4. Recommends to the General Assembly that member States pay their contributions to the budget for 1990-1991 in United States dollars and pesetas in the proportion of 40 per cent in dollars and 60 per cent in pesetas and that the share of contributions payable in pesetas be calculated on the basis of the United Nations operational exchange rate applicable in August 1989.

Consideration of the new text of the formula adopted for fixing the contributions of member States (decision CE/DEC/17(XXXV))

Agenda item 3(d) (documents CE/36/3(d) and CE/36/3(c))

The Executive Council,

Recalling its decision 17(XXXV) in which it decided to recommend the General Assembly to adopt the revised formula for fixing the contributions of member States,

Having considered the new text of the revised formula prepared by the Secretary-General in cooperation with the Chairman of the Committee on Budget and Finance,

- Recommends the General Assembly to adopt the new text of the revised formula for fixing the contributions of Member States, as contained in Annex 1 to document CE/36/3(d) (document A/8/12(a)(b)), as modified by the Council at the proposal of the Committee on Budget and Finance (document A/8/12(a)(b) Add.1)), so that it may be applied in apportioning the budget for 1990-1991; and
- 2. Also recommends the General Assembly to suspend application of its resolution 22(II) which placed San Marino in the last group of contributing countries, and that San Marino be placed in the penultimate group, irrespective of its position in the classification of countries according to their capacity to pay.

Having taken note of the letters to the Secretary-General from the Full Members Bolivia, Chad, Mali, Niger, Uganda and Venezuela and the Affiliate Member Tourconsult/Italia, in which they request suspension of the application to them of the provisions of paragraph 13 of the Financing Rules attached to the Statutes and submit plans for the payment in instalments of their contribution arrears in accordance with General Assembly resolution 162(VI),

Recommends the General Assembly to suspend the said provisions as they apply to the Full Members Bolivia, Chad, Mali, Niger, Uganda and Venezuela and to the Affiliate Member Tourconsult/Italia, on condition that they comply strictly with the plans they have submitted to the Secretary-General for discharging their arrears and that in the case of Bolivia, Chad, Mali, Niger and Uganda, they pay their outstanding contributions for 1989 by the end of the year;

II

Having taken note of Iraq's letter to the Secretary-General in which it puts forward a plan for the payment in instalments of its arrear contributions,

Recalling its decision 3(XXXI), in which it recommended to the General Assembly that the provisions of paragraph 13 not be applied to Iraq until the extraordinary circumstances it had invoked no longer existed and provided it undertook to draw up a plan for the payment in instalments of its arrear contributions,

2. Recommends to the General Assembly that the provisions of paragraph 13 of the Financing Rules attached to the Statutes not be applied to Iraq, on condition that it complies strictly with the plan it submitted to the Secretary-General for discharging its arrears and pays its outstanding contribution for 1989 by the end of the year.

The Executive Council,

Having taken cognizance of the report of the Secretary-General on the application of Article 34 of the Statutes,

<u>Having considered</u> the report of the Committee on Budget and Finance on this subject,

- 1. Notes that, in accordance with General Assembly resolution 217(VII), the measure of suspension is currently applied to the eleven Full Members and seven Affiliate Members listed in Annex 2 to document CE/36/4(c); and
- 2. Further notes that the six Full Members and eight Affiliate Members listed in Annex 3 to document CE/36/4(c) have accumulated arrears equal to their contributions for four financial years and that, pursuant to paragraph 1(b) of General Assembly resolution 217(VII), they are consequently liable to the measure of suspension provided for in Article 34 of the Statutes.
