<u>Having taken note</u> of the circulation to Full Members, at the request of the WTO Commission for the Americas, of a draft amendment concerning the status of the WTO Regional Commissions within the Organization,

Requests the Secretary-General (1) to transmit to Full Members the complete text of resolution CAM/5/RES/4 of the WTO Commission for the Americas, in accordance with Article 33 of the Statutes, and (2) to draw the attention of said Members to the need for the General Assembly, on account of the statutory difficulties that implementation of said resolution would involve, to take a decision in principle at its third session on the said resolution before considering what further action should be taken on the matter; and

<u>Entrusts</u> the Secretary-General with continuing his action in that sense; and

<u>Requests</u> Members to take all possible steps to support the action of the Secretary-General.

Recalling Article 12(c) of the Statutes and rule 29(1) of its.
Rules of Procedure,

Having held a private meeting in accordance with rule 29(2) of its Rules of Procedure and the relevant provisions of decision 6(IX) taken at its ninth session,

<u>Having voted</u> during that meeting by secret ballot in accordance with the Guiding Principles for the Conduct of Elections by Secret Ballot attached to the Rules of Procedure of the General Assembly,

<u>Recommends</u> to the General Assembly that it renew the term of office of Mr. Robert C. Lonati (France) as Secretary-General of the Organization for the period 1980-1983.

#### Financial matters

Agenda items 5 to 10 (documents CE/10/5, CE/10/6, CE/10/6 Add.1, CE/10/7, CE/10/7 Add.1, CE/10/7 Add.2, CE/10/8, CE/10/9, CE/10/9 Add.1, and CE/10/10)

The Executive Council,

<u>Having taken note</u> of the report of the Chairman of the Committee on Budget and Finance on the proceedings of the third and fourth meetings of the Committee, and

Having taken note of the report of the Auditors on the accounts for the financial year 1978,

#### <u>Decides</u> the following:

(a) Recalling its decision 23(IX) by which it adopted the draft general programme of work for the period 1980-1981 with certain changes,

<u>Having examined</u> the draft programme budget (document CE/10/5) drawn up by the Secretary-General on the basis of that decision,

Considers the increase that said draft programme budget shows over the budget for the previous period to be excessive, in view of the concerns expressed by the majority of States Members concerning their capacity to pay; and

Recommends to the General Assembly that it approve the draft programme budget as reduced on the basis of the recommendations expressed by the Committee on Budget and Finance in its report (document CE/10/9) and as reproduced in Annex 1 to said report;

(b) <u>Having examined</u> the final accounts for the financial period 1976-1977 (documentsCE/10/6 and CE/10/6 Add.1),

Recommends to the General Assembly (1) that it approve said accounts, and (2) that it approve, subject to the provisions of paragraphs (c) and (d) below, the apportionment of budgetary surpluses proposed in document CE/10/6 as complying with the Financial Regulations of the Organization;

(c) Noting that application of the Financial Regulations of the Organization leads to budgetary surpluses being apportioned to States that have not paid their contributions during the financial period in question,

Recommends the General Assembly, in order to avoid a similar situation in future, to amend subsections (a) and (b) of regulation 5(2) of the Financial Regulations by substituting the word "actual" for the word "assessed" in the phrases reading "in proportion to their assessed contributions for that financial period";

- (d) Recommends to the General Assembly that miscellaneous income for the financial period 1976-1977 be apportioned among the Members of the Organization in the same way as the budgetary surpluses for the same period;
- (e) <u>Considering</u> that Singapore and Trinidad and Tobago fulfilled all their obligations during the financial period 1976-1977,

<u>Recommends</u> to the General Assembly that said States receive the portion of the budgetary surpluses to which they are entitled in respect of that period;

(f) <u>Having examined</u> the administrative accounts for the financial year 1978,

Takes note of the balance-sheet as at 31 December 1978, the position of allocated appropriations, expenditure and available balances for the financial year 1978, and the transfers between headings or items of the same section authorized by the Secretary-General during that year;

(g) Requests the Secretary-General to have a quantified inventory of publications made during the financial year 1979, as urged by the Auditors of the Organization;

- Decides, with regard to the use of miscellaneous income, (h) (1) that the contributions of Associate and Affiliate Members for the financial year 1978 shall be integrated endinto the budgetary receipts, (2) that, notwithstanding the provisions of paragraph 5 of the Financing Rules attached to the Statutes, miscellaneous income in 1978 coming from sources other than the above-mentioned contributions shall be paid into the Working Capital Fund, and (3) that for financial years after 1978 the contributions of Associate and Affiliate Members shall no longer be entered under miscellaneous income but assigned directly to budgetary receipts and other income now included in sundry receipts shall, notwithstanding the provisions of paragraph 5 of the Financing Rules attached to the Statutes, be paid into the Working Capital Fund;
- (i) Noting with concern the continuing failure of a number of States Members to observe their financial obligations to the Organization,
  - Recommends the General Assembly to apply to those States the provisions of paragraph 13 of the Financing Rules attached to the Statutes;
- (j) Notes with satisfaction that the administrative accounts are now supplemented by a statement on the operations carried out by WTO as an executing agency of the United Nations Development Programme;
- (k) Recalls the Secretariat's obligation, in accordance with regulations 10(3) (c), 13, 14 and 17 of the Financial Regulations, to submit to the statutory bodies of the Organization audited accounts concerning the management of funds made available to the Regional Secretariats and CIEST; and
  - Requests the Secretary-General to submit to it, insofar as possible, at its eleventh session said audited accounts as from 1 January 1978;
- (1) Considering the matter of the disposition of credits in the Working Capital Fund of States which have ceased to be Members of the Organization (document CE/10/7 Add.1),

<u>Recommends</u> to the General Assembly that the sums due to the Government of Trinidad and Tobago be refunded without delay and that the Government of Singapore be informed that sums which it has paid into the Working Capital Fund are held by the Organization at its disposal;

(m) Considering that ordinary expenditure arising each year from the payment of terminal grants to staff of the Organization can be covered by the appropriations in the relevant heading of the budget and that in the event of expenditure for the payment of such grants exceeding those appropriations the Executive Council may as and where necessary authorize the Secretary-General to make transfers of credits,

<u>Considers</u> that it is not appropriate to set up a special fund for terminal grants payable to staff on separation from service;

(n) <u>Stressing</u> again the importance of a study on the needs of the Affiliate Members,

<u>Authorizes</u> the Secretary-General to finance that study from the available balance for the financial year 1978;

(o) <u>Having noted</u> the view of the CBF on the Secretary-General's question whether CIEST activities could be included in the general programme of work of the Organization,

Accepts the conclusions of the Committee on Budget and Finance that the question appears to call for an affirmative reply but that, in the absence of any budget estimate or any accounting information about the operation of the Centre, it is difficult for the Council to reach a decision on the nature of any budgetary assistance for CIEST until quantified data are available; and

Requests the Secretary-General to provide such data at its next session, in order to enable it to determine said assistance;

(p) <u>Having examined</u> the request by Lebanon for exemption from its contributions for the financial years 1978 and 1979,

Having noted that this member State has paid its contribution for 1978,

Considering the situation prevailing in that country,

<u>Recommends</u> to the General Assembly that Lebanon be exempted from its contribution for the financial year 1979.

#### Vocational training activities

The Executive Council,

Having taken note of the Secretary-General's report on vocational training activities and on contacts in this connection with the Mexican Government, the United Nations Development Programme and the Venezuelan Tourism Corporation,

<u>Having noted</u> the assurances of the delegation of Mexico that the necessary measures have been taken for courses of the International Centre for Advanced Tourism Studies (CIEST) to be resumed from August 1979,

<u>Having been informed</u> by the delegation of Venezuela that its Government is withdrawing its offer to establish a World Hotel Training Centre at Caracas,

Entrusts the Secretary-General (1) with continuing his approaches to UNDP or other possible sources of financing, in order to supplement Mexico's contribution to the operation of CIEST, and (2) with taking appropriate measures following the withdrawal of the offer by Venezuela.

The Executive Council,

Having noted the measures taken by the Secretary-General pursuant to its decision 2(IX) and the proposals made by the Swiss Government and the Spanish Government concerning the transfer of the functions of depositary of the Organization's Statutes,

Recalling General Assembly resolution 28(II) and its own decisions 15(VII) and 2(IX),

Takes note that the functions of depositary of the Statutes will be transferred from the Swiss Government to the Spanish Government on 1 May 1979 and that the Secretary-General, in accordance with the provisions of Article 33 of the Statutes, will communicate to the Members of the Organization a draft amendment to Article 37 of the Statutes to the effect that said Article shall read:

#### "Article 37

- "1. These Statutes and any declarations accepting the obligations of membership shall be deposited with the Government of Spain.
- "2. The Government of Spain shall inform all States so entitled of the notifications and declarations received by it, in accordance with the provisions of Articles 33 and 35."

<u>Entrusts</u> the Technical Committee for Programme and Coordination with examining these questions at its next meeting in the light of the observations expressed during the Council's discussion of this item, and submitting its conclusions to the subsequent session of the Council; and
